
RESPONDENT'S MOTION FOR EXTENSION OF TIME



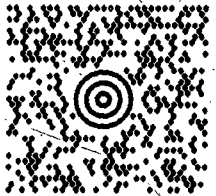

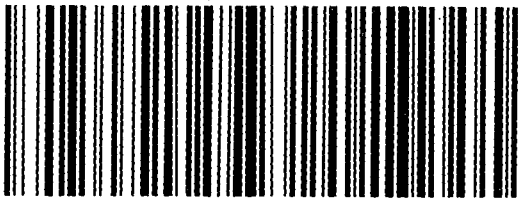
