I am in receipt of the letter you sent in regards to my appeal for Georgetown County court case number 2013-CP-22-01079.



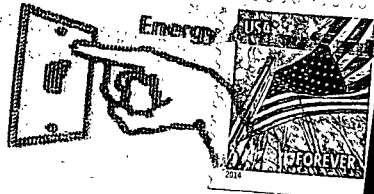
