- (5) August 28, 2014 Order by Administrative Law Judge S. Phillip Lenski.



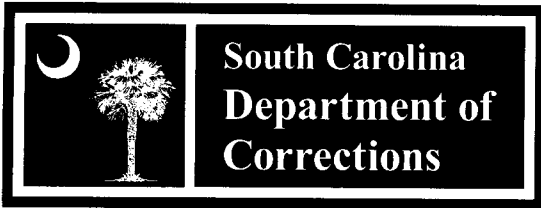
