

Drugs / Trafficking in cocaine base - 28 grams or more but less than 100 grams

That in Jasper County, South Carolina, on or about February 24, 2012, the Defendant, Derrick Roberts, knowingly did sell, manufacture, deliver, purchase, or bring into this State; or did provide financial assistance or otherwise aid, abet, attempt, or conspire to sell, manufacture, deliver, purchase, or bring into this State; or did possess or attempt to possess a controlled substance or a controlled substance analogue, to wit: cocaine base, in excess of 28 grams but less than 100 grams; in violation of 44-53-375 of the South Carolina Code of Laws (1976) as amended.
