
If I may be of any further assistance to this Office, in these matters, please do not hesitate to contact me. Thank you for this Office's time and attention to these matters.

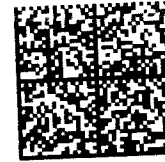
