trial please help me with this thanks God bless.

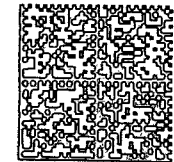

at all. I wanted to appeal this because me and my lawyer wasn't getting going  
any more. We only spoke 3 times 2 times on my case my case was serious I needed more time  
I was told I could get a deal of 1585% in 1000 2013 and I emailed  
her on the kiosk at county jail about it when I spoke to her June 2014 she  
denied knowing anything of it that shows she new nothing of my case also I was  
offord to get the burglary and grand larceny dropped if I took open  
plea 0 to 30 I got this all on paper but she came the next day with  
papers with a 20 year plea deal I insisted I rather get  
charges dropped and go with 0 to 30 but she took upon herself to not  
let me get that deal I have in writing I submitted several  
times to clay allen on kiosk about problems with Mrs Hall,  
also I've written to clerk of court trying to find out how to  
dismiss her with I have documents and all emails are  
kept on file as well I didn't do the burglary I stated that from the  
get go I never tried killing kip teal and video even shows  
that the cop lied about the assault and bett High aggravated  
nature abhan, I was high on drugs and slipped bath  
salt I didn't even know where I was for several weeks  
I was supposed to have seen mental health but Clair  
Hall lied about that I've never saw knowbody I sent a  
letter a motion to dismiss council on July 3rd 2014  
I also gave Mrs Hall a motion to dismiss council she was ferious  
and said that I could not fire her then stated that judge  
wasn't going to accept it she came back with a  
big black dude and he measured me he left  
came back with a suit and shoes she told me that  
by me trying to fire her I'd have to go to trial  
today with or without her and I'd probably get  
life I got scared she told me have you.

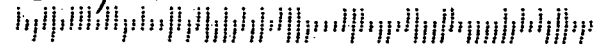
