MOTION FOR EXTENSION OF TIME


the initial Brief and Designation of Matter to be included in the Record on Appeal within an additional thirty (30) days.



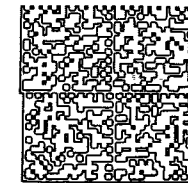
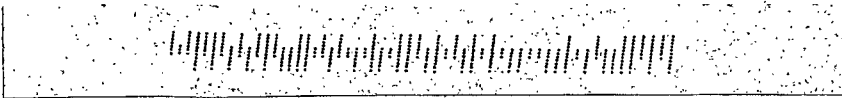
