MOTION FOR AN EXTENSION IN WHICH
TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND BRIEF OF APPELLANT
PURSUANT TO WHITE V. STATE WITH
ADDITIONAL APPENDICES




4. This request is made in good faith and not for purposes of delay.


