

DISMISSAL AGREEMENT



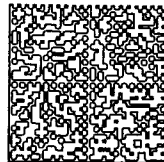
