Dear Ms. Kitchings:

Appellants in the above-referenced matter recently requested the transcript from the hearing below from the Sumter County Circuit Court. We received word last week from the court reporter, Margaret T. Sullivan, that her backlog is quite extensive, and it will be some time before she can provide us with the transcript. Pursuant to Rule 208 of the Appellate Court Rules, Appellants will plan to submit their Initial Brief and Designation of Matter within thirty days following the receipt of this transcript.

Appellants also note for the Court that Judge Young's order currently being appealed has never been filed by counsel for the Second Injury Fund with the Clerk of Court's office in Sumter County. Appellants received a copy of a letter dated September 25, 2014, from Mr. Killen to the South Carolina Workers' Compensation Commission by which he provided a copy of Judge Young's executed order, but, to Appellants' knowledge, this executed order has never been filed with the Court below. Out of an abundance of caution, Appellants appealed the executed order which was dated September 5, 2014, and Appellants will provide a copy of the final order to this Court upon receipt of the same from the Court below or from the Fund's counsel.


