3. Order Denying Appellants' Motion to Reconsider from The Honorable R. Keith Kelly dated October 6, 2014.


Pursuant to Rule 56, SCRPC, the denying of the order is immediately appealable. Appellant received written notice of entry of this order on October 10, 2014.
