This case concluded and a remitter was sent by the Court of Appeals to the Clerk of Court for Anderson County.

Under the date of April 11, 2014, Corrie Martin subsequently filed a Notice of Appeal with the Court of Appeals, a copy of which is attached, which uses the case style of Corrie Martin v Green Tree Mortgage, Appellate Case No.: 2014-CP-04-00463.

The Notice of Appeal reads:

“Pursuant to the Order of Ellis B. Drew, Jr. I Corrie Martin do appeal order set for on March 31, 2014. Pursuant to Rule Civil Procedures Rule 55, Attorney Fees, Rule 201 Right to Appeal and Rule 224(j) SCARCR (“Any party aggrieved by an order of an individual judge or justice may seek review or that order by the appellate court or a panel thereof.”) Pursuant to Section 17-23-110 after discovered evidence 1,2,3,4 of section, I also appeal order.”

The Notice of Appeal was filed by Corrie Martin –personally in that the Notice of Appeal does not show the name of an attorney.

Ms. Corrie Martin subsequently filed and served a Motion of Stay, Sworn Affidavit, Motion for Hearing Stay, together with Proof of Service.


Ms. Corrie Martin also filed Motion to Extend Time for filing her Initial Brief.

On October 21, 2014, I mailed correspondence to Ms. Corrie A. Martin asking for further information concerning these papers. She did not respond. 

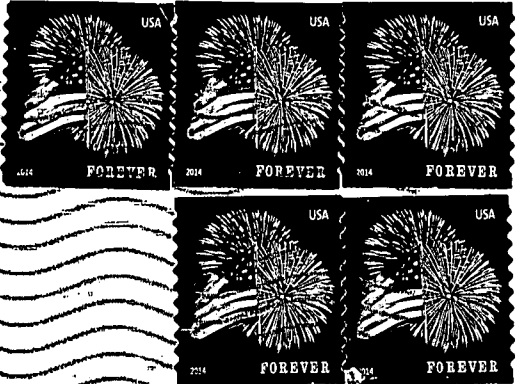
