




Dear Ms. Abbot-Kitchings

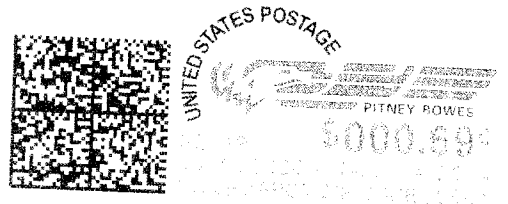
