I accepted full responsibility for my actions and still do, but I feel this is entirely too harsh! Please Help me! My lawyer coaxed me into taking this "Open Plea" with the assurance that it was going to be midimal time, This is Maximun! 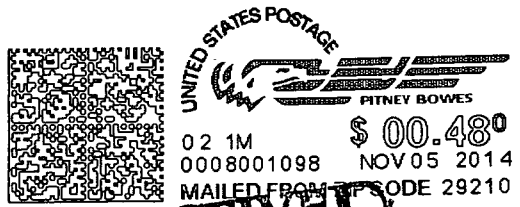
