AMENDED MOTION TO AMEND DESIGNATION OF RECORD ON APPEAL

The Appellants, Howard Nankin and Nancy Nankin, filed a motion with this court on November 14, 2014 to amend their Designation of Record on Appeal. Previously, Appellants filed a Designation of Record with their Initial Brief on June 13, 2014 and a supplemental Designation of Record on November 6, 2014. The items designated in the November 6th filing are intended to be considered in addition to the items designated in the June 13th filing. 
