Also, I would like to point out that I was under the impression that I was being represented in this matter by the SC Commission on Indigent Defense. Please see the Certificate of Mailing filed in this case on September 10, 2014 by the Fairfield County Clerk of Court, Betty Jo Beckham. The lower court case No. is 2014-CP-20-163, this is a Habeas Corpus and I believe I have a Constitutional Right to Counsel on appeal.

However, it appears that the Judge denied my Motion to appoint Counsel (and furnish a transcript) on 11/10/2014. Therefore, I have enclosed an original and one copy of my Notice of Appeal. Please file the original and return the clocked-in copy.
