Several more errors in my Case

Prejudice (1) my right to due process because section 1-7-330 permitted the solicitor to judge shop. My case was supposed to be tried in November of 2013. But the Solicitor supposedly came down with a cold. And my case was called February 2014 in front of Judge Brown who is known for giving the maximum of Sentences.

(2) I was also denied the right to a speedy trial

Due process Right = was violated.

I clearly told my Lawyer I didn't want to go in front of Judge Brown because he is well known for giving people a lot of time. My Lawyer stated I have no choice and I didn't get to pick the judge! (Mis ineffective Counsel)

< Ian Gause = the alleged incident happened at 11:00 pm. Approx. Ian was pronounced dead at 1:39 AM ^(at hospital) the next day. That's a window of 2 hours. What type of surgery took place? and what (amount) drugs were administered? and did they have an effect on the alcohol & marijuana he already had in his system? what does the death certificate say?

In addition my Lawyer Ralph Wilson has proven himself to be ineffective of counsel by not calling my only witness to the stand (Lemont Davis) who sat behind me who clearly said he saw Ian Gause pointing a gun at me before he ran. see C.D.'s

Also why wasn't Kye Graham charged with accessory with murder if he

didn't believe I acted in Self Defense and road with me to the night club? Why didn't he call the Police on me. Instead of riding with me.

(Rishawn's) C.D. Also Please pay close attention when listening to Rishawn's audio statement he tells how Ian Gause ran back on me and that's when Ian got cut and Rishawn saw this when he hit me then he got cut! But he doesn't mention if they had there (guns) in their hands while they fought with me pistol whipping me and then shooting at me (check their guns 4 shots were fired (1) from Ian and (3) from Rishawn Gause

(Evaluted Before Trial)

should I have been evaluted before or sent to Columbia

This is a Brady Evaluation and Due Process Violation to see if competent for trial I was suffering from severe emotional distress

[Kye Graham] mother stated she didn't want Kye to take the stand because he has mental issues this wasn't investigated but mentioned by the public offender Vick Meetz but never had it done and Kye still took the stand against me!

"Please Note")

1) Rishawn Gause states "that he tries to hold his brother back from (On C.D.) coming towards me but he keeps coming on gets stabbed referring to his brother Ian.

2) Charlie Wilson states in trial he tries to hold Ian Gause back to (not in) (motion of discovery) the point where he even tries to wrestle him to the ground only Trial but he brakes away and still comes after me. And doesn't continue because he was scared of getting shot

3) Lamont Davis says before he ran Ian Gause was pointing a gun at (on C.D.) me at chest level before he ran and then heard a shot fired while he was running! (Conflicting statement)

4) Kye Graham says he tried to break it up during interrogation. But (on C.D.) in court admitted he didn't because he was too scared

Clearly SELF-DEFENSE!!!
