Dear Honorable Ms Kitchings,



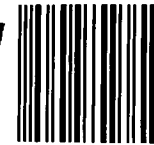

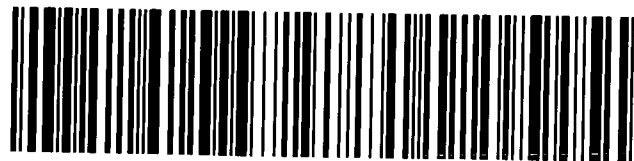
