
Notice is hereby given that Justin Turner # 330518 does hereby appeal the final decision of the South Carolina Administrative Law Court dated Sept. 25, 2014 and received on Sept. 29, 2014, a copy of which is attached. A general statement of the grounds for appeal is:

I received back from the Administrative Law Court an Order of Dismissal with prejudice stating that I did not claim Liberty Interest or State Liberty Interest in my grievance in which at the time I was "law illiterate" so I did not know to add that but I did put that in my notice of appeal to the A.C.C. which is what ultimately matters the most but which is only half of the problem because my 14th Amendment of Due Process was violated, plus SCDC policy was not followed. I was also given a false extension memorandum letter being held on lockup for 96 days without a hearing.

The A.C.C. Judge Matthews did not acknowledge my motion for extension of filing my brief because the law library gave me the runaround for almost 3 weeks of getting in the law library to complete my brief to meet my deadline, instead of acknowledging my motion for extension I get an Order of Dismissal.

One complaint was turned around stating I could only file 3 complaints a year free then every one afterward requires a \$25.00 filing fee. That was grievance no.: LCI 435-14 which just so happens to be the complaint that was turned around, if I had a choice that complaint would be stayed because that was the whole point reason for me taking it to the A.C.C. because that's the charge that good time was taken away.


