

MOTION FOR EXTENSION OF TIME TO FILE REPLY BRIEFS

Appellant Carolina Regional Cancer Center asks this Court for an extension of time in which to respond to the Initial Briefs of Respondents South Carolina Department of Health and Environmental Control ("Department") and Grand Strand Regional Medical Center, LLC ("Grand Strand), filed on November 4, 2014.




