Notice of Appeal

I, William T. Watts II, am appealing the decision not to allow me to have witness and evidence in my favor during a involuntary commitment hearing held on Oct. 16, 2014 before Judge Thompson case 2014MH3200360.

I requested a postponement of the hearing while I appealed to the Supreme Court of the United States. Judge Thompson proceeded with the hearing even though I am appealing to the Supreme Court of the United States and when I requested a summons and an order to produce evidence for the FBI, Judge Thompson stated that I must do that before the hearing which violates the right to due process and the right to have evidence and witness in my favor.

It seems Judge Thompson has decided to postpone her decision while I appeal which gives her time to order the FBI to produce and she has not.

① The Lexington County Clerk of Court is not filing my motions, petitions, or anything, which has confused me and made me hesitant to file anything in Lexington County. It is a trick and manipulative and violates the right to Due process.

② Judge Thompson allowed me to represent myself, then refused all other request; postponement of the hearing and a summons for witness and an order to produce evidence. Refusing to allow me evidence to rebuttal (direct rebuttal) the evidence introduced by the State violates the right to Due process and the right to have witness and evidence in my favor. The refusal to postpone the hearing and or to schedule another violates the right to Due process.

③ The Clerk not filing petitions and the Judge not allowing me to request verbally in court makes it impossible to effectuate constitutional and civil rights.

I am requesting a summons and an order to produce for the FBI. I am requesting a rehearing or another hearing to introduce the evidence. I am requesting an order to compel the Lexington County Clerk of Court to file and respond to my motions, petitions, subpoenas, ect. I am requesting the transcript of the hearing to prove my objections.

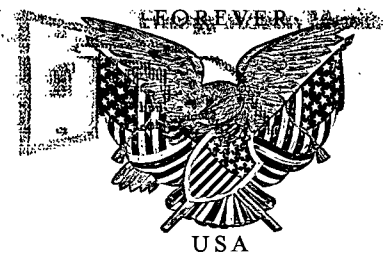
