Appellant's motion to strike Respondent's Return to Appellant's motion to hold Appellant in abeyance.

Appellant received Respondent's Return on 11-18-14 - at approximately 7 pm.

Appellant moves to strike Respondent's Return, as fails to state a claim to which relief can be granted, and contains immaterial, impertinent and scandalous matter and for submitting an affidavit made in bad faith, 3d Level Hearsay, see hereto Appellant's memorandum in support of this motion to strike Respondent's Return.

1. Appellant filed motion requesting to hold Appellant in abeyance when state SCDMH supervising employees unlawfully confiscated Appellant's legal files i.e. 26 computer floppy disk, in retaliation, searching persons who have incriminating evidence, or who had helped or will testify against state employees facing criminal charges and suit in U.S. District Court for assault, sexual assault, abuse of SCDMH sup

- Residents, to which Appellant is a witness in chief.
2. Respondent can find out has caused Appellant to not have access to files/documents (He) has been ordered by this court to produce in a Supplemental Record on Appeal.
 3. Respondents Return contain incoherent ranting; Bad mouthing, mud slinging, speculative assertions, consistent of a person who is guilty Retentive, trying to obtain a ruling based on hearsay, attempting to conceal Respondents many years of making false statements and with holding exculpatory evidence against this Appellant as proven by the statements of Paul and supporting documentation in Record on Appeal. ie Stricken Record on Appeal; initial appeal brief
 4. Respondent submitted an affidavit of Holy Senturo, made in Bad Faith, containing 2-3 level Hearsay and mislead, false statements by an affiant who herself is under investigation for retaliating and obstruction of Justice against Plaintiff and witness in U.S. District Court cases
