And get me into court. He is to straighten out the mess created by the public defender Vic Moore.

Scott Floyd is to also get the appeal filed immediately. This is the first letter I can get out to your office SC Court of Appeals. I cannot communicate out from territorial Inbaran but I believe I can get to the mail room and mail out this letter. I will win this appeal. Because I was railroaded with malice involved.

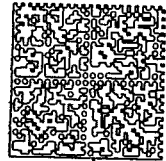
