**MOTION TO CORRECT THE AMENDED RECORD ON APPEAL**


The Respondent Donald V. Myers respectfully moves this Court for an Order requiring the Appellant to file and serve a Second Amended Record on Appeal that fully complies with the South Carolina Appellate Court Rules and that includes the following corrections, in addition to those already required by the letter dated November 13, 2014, from Claire Allen to the Appellant:

1. The Index of the Amended Record on Appeal, as filed by the Appellant, does not show sequential page numbers. The Plaintiff appears to have given each document in the Amended Record on Appeal a number from 1 to 12, and those are the "page numbers" listed in the Index. Those do not correlate to the remainder of the Amended Record on Appeal which contains no sequential page numbering at all.

2. The Amended Record on Appeal, as filed by the Appellant, still does not comply with the Supreme Court's Revised Order Concerning Personal Identifying Information and Other Sensitive Information in Appellate Court Filings, issued April 15, 2014. While it appears that the Appellant made an effort to comply with that Supreme Court Order, he has actually redacted much more than required by the Order. The Appellant has redacted numerous names of persons (not limited to minors) including parties and judges and even case names as contained in the Complaint and motion hearing transcript. Those redactions make large segments of those documents impossible to read or comprehend as a result.

The Respondents request that the Court continue to hold all deadlines in abeyance until the issues regarding the Record on Appeal are resolved.
