Counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in the case of Xavier Perry v. State with this Court on November 10, 2014. Counsel had an oral argument in the case of State v. Maurio Rivers in the Court of Appeals on November 5, 2014. Counsel filed the petition for rehearing in the case of the State v. James Harris with the Court of Appeals on October 30, 2014. Counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in the case of Randy Crosby v. State with this Court on October 27, 2014.

3. As indicated by his consent below, counsel for the state does not oppose this request.

4. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.




