
We are respectfully requesting a thirty (30) day extension of time to request the transcript in this case pending my client's determination of indigency with the Division of Appellate Defense.



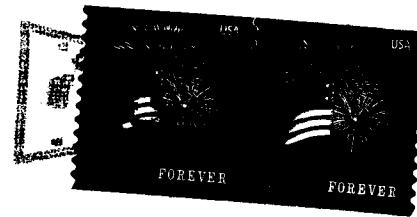
