




This case was tried before the Honorable Eugene C. Griffith, Jr. and a jury on November 10, 12, 13, and 14, 2014.

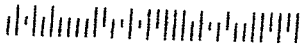
