SECURITY FEATURE	DESCRIPTION FOR FEATURE
Heat Sensitive Lock/Icon	Requires heat to be applied when copying or scanning. Changes color when the icon is exposed to heat.
Toner Adhesion	Chemical treatment on the sheet that causes the toner to adhere better when run through a paper copier.
True Watermark	Watermark appears at paper mill. Held up to light to observe. Prints clearly into the paper that become visible under UV light.
Fluorescent Fibers	Fluorescent fibers are embedded in the paper. They react to chemical alteration leaving a visible stain on the surface.
Chemical Reactivity	Chemical treatment on the paper that causes it to react to heat, moisture, and other environmental factors.
Control Background	Controlled background color and texture. All background features are present.
Micro Printing	Micro printing on the paper. When copied, appears as a fine, illegible pattern.
Security Backer	Security backer is a certification mark of the document.
