
Dear Mr. Greene:

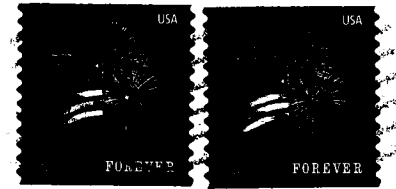
