I am, an appellante, represented by Robert Dudek. Before going any further I must apologize for disturbing your valuable free time, but I have an issue I pray you are willing to lend to your guidance and expertise. In my case the Court handed down an order holding the time limits in obedience until pre-trial transcripts, which took place under the lower Court of Judge Diane Goodstein, were ~~not~~ ordered by Appellate Defense. The Order was of course preceeded by a motion from the State. Your Honor my issue is this, the trascripts from, Court reporter, Bonnie Kelly which pertain to all hearings held in front of Judge Goodstein were recieved as of July 8, 2014. A few days later, of that date, I spoke with Mr. Dudek and he assured me "the clock is ticking again" and we'd be moving forward. After not hearing from Counsel in regards to progress on the case I inquired as to that matter. As of Oct 15 2014, I was informed we are now waiting on transcripts from hearings that Mr. Dudek was not ordered to obtain. When I attempted to refer to the Court Order, and ask why Mr. Dudek would allow the State more time that they essentially shouldn't have, my inquiries (4 of them by letter & phone) have been ignored. I have not heard from Counsel since then, which is odd since his office usually responds within 8-10 days as they have been for 3yrs now. I would also point out that one of these transcripts was ordered 9 months ago and again my Counsel sees no need to question this abnormal amount of time. I pray that your Honor would grant me new counsel outside of the appellante defense office and/or Order the state to forgo their response as they are past their time limits and have made no motion for a reasonable extension. I thank you for your time and consideration in this matter. Happy Holidays.
