references.


However, this request brings up a matter that I want to
address and I want to make sure that I have complied with rule
211. I have sent for filing the Final Brief of Appellants and the
Reply Brief of Appellants. While preparing the Final Brief, I
changed the references in the initial brief to conform with the
Record on Appeal. There were at least 2 pages referred to which
were incorrect in the initial brief and I revised those and added
the lines involved throughout and added one other page to an

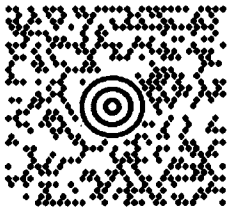

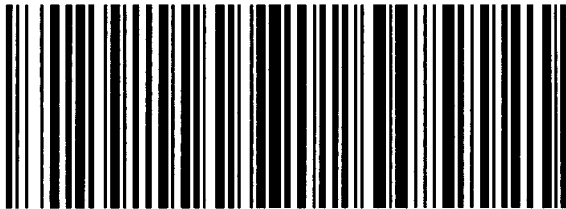
