

Judge Nicholson denied the motion for reconsideration in a form order dated October 28 and filed October 30. Ms. Wilson has never received written notice of the entry of this order. One of her lawyers discovered the order during a routine check of the docket. Because the deadline to serve a notice of appeal does not start until a party receives written notice that an order has been entered, this appeal is timely. See Rule 203(b)(1), SCACR.


