




RULE 203(d)(1)(B)(iv) EXPLANATION




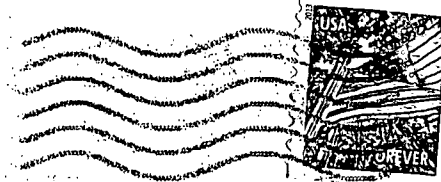
