1 The initial brief of appellant and designation of matter in this case are due to be served and filed with this Court on December 8, 2014


2 After being appointed as co-counsel for this case, the undersigned counsel resigned his employment with his prior law firm, Ogletree, Deakins, Nash, Smoak &
