

Responding in order below . . .

The correct spelling of his last name is "Silvaggio" and it was probably February 3rd "or" 4th . . .

The only cases that I can remember being handed up where McClurg v. Deaton, 716 S.E.2d 887, 395 S.C. 85 (2011) and Richardson v. P.V., Inc., 682 S.E.2d 263, 383 S.C. 610 (2009). However, I also have the BB&T v. Taylor, 633 S.E.2d 501, 369 SC 548 (2006). I'm not 100% sure it was handed up.

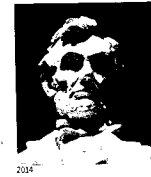
