I am the Appellant in the above captioned appeal. My Final Brief, Final Reply Brief and Record on Appeal are due for filing on today's date. The Record on Appeal was served on opposing counsel on October 23, 2014 and the Certificate of Service was mailed for filing that same day. Mr. Ryan subsequently advised me that the Record on Appeal met with his approval. Unfortunately, when preparing the Final Amended Brief of Appellant we discovered a clerical error. In my Designation of the Matter filed along with my Amended Initial Brief, I inadvertently left off my request for a copy of my time records, as attached to my SCCID Voucher, to be included in the Record on Appeal. 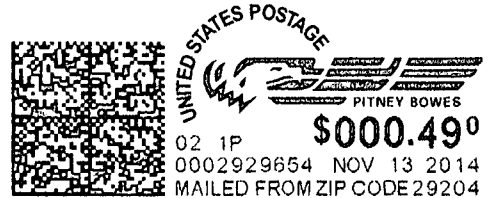
