

Based on the current rate, the estimated cost will be \$65. **Upon receipt of a CERTIFIED CHECK OR MONEY ORDER in the amount of \$65, I will be able to place your request in line for typing.** If the transcript is less than 20 pages, I will refund the difference to you upon delivery of the transcript. If the transcript is more than 20 pages, the balance will be due prior to delivery of the transcript.

Under our rules, I have sixty days in which to complete the transcript, after receipt of the deposit. In addition, I am allowed to request from Court Administration thirty day extensions, if necessary, to complete the transcript. You will be notified if extensions are granted.

If you desire to cancel the request for the transcript after the deposit is sent, a cancellation request must be made in writing. You will be responsible for payment of any portion of the transcript that has been completed.



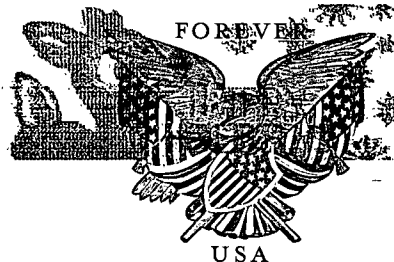
