
The Appellant, London Kelley, pursuant to Rule 240 SCACR, hereby petitions the Court to allow late filing of the Amended Notice of Appeal and the required Affidavit of Indigency in this case. In support of this petition, counsel submits the following information to the court.

1. The trial of the Appellant listed above was held on 10/31/2014 before Judge George C. James, Jr., Wherein after, the appellant was found guilty of Accessory After the Fact to Murder.
2. The Appellant's Notice of Appeal was served on all parties on November 7, 2014 and was filed on November 7, 2014.
3. On November 18, 2014, Appellant's counsel received notice from the Court that a deficiency was noted during a review of the Notice of Appeal.
4. On November 18, 2014 Appellant's counsel received notice from the Office of Indigent Defense that their office could not represent the Appellant without a completed and signed Affidavit of Indigency
5. This request is based upon the Appellant being indigent and unable to pay her trial counsel or any counsel to take said representation for her appeal.

6. That a request will be made to SCCID for assistance and an Affidavit of indigence will be submitted to SCCID.


