MOTION FOR COSTS

Pursuant to Rule 222 of the *South Carolina Appellate Court Rules* (SCACR), Respondents request that the costs of this appeal be taxed against the Appellant, F.M. Haynie (d/b/a Docwild's General Contract), in the amount of one-thousand one-hundred fifty-three dollars and forty-nine cents (\$1,153.49) as shown on the sworn, itemized statement of costs accompanying this motion.

Rule 222(a) provides that unless the court orders otherwise or the parties agree otherwise, costs shall be taxed against the appellant when the judgment on appeal is affirmed. This Court affirmed the master-in-equity's order on December 23, 2013. The Appellant filed a Writ of Certiorari to the South Carolina Supreme Court which was denied on November 7, 2014. The remittitur was issued on December 1, 2014. Because the Court has not ordered otherwise and the

parties have not agreed otherwise, Rule 222 provides the Court should award costs to the Respondents.

The costs sought to be recovered are for printing the final brief and attorneys' fees, each of which is authorized by Rule 222(b), SCACR. The undersigned certifies that the costs were necessarily incurred and believes that the taxation against Appellant is appropriate under Rule 222, SCACR.






