CONTINUANCE**



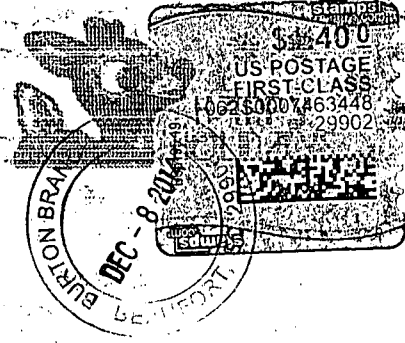
