INITIAL BRIEF AND DESIGNATION OF MATTER**


TO: THE JUDGES OF THE SOUTH CAROLINA COURT OF APPEALS





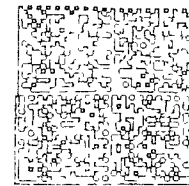
