
Pursuant to the Order of Judge Cureton dated November 13, 2014 please allow the following to serve as a brief update in the above-referenced matter. A hearing was held pursuant to this Court's Order on December 4, 2014. At the hearing, it was ordered by the trial court that proposed orders would be submitted by the Attorney General and Sue Summer regarding the production of documents and attorney's fees by December 27, 2014. Responses of each side to the proposed orders are then due on January 7, 2015.

At the hearing counsel for the Proposed Intervenor reiterated the Proposed Intervenor's understanding that the hearing was strictly to address issues remaining to be decided between the Attorney General and Summer. It was made to appear that the trial court would rule on all outstanding issues after the January 7, 2015 responses by Summer and the AG, and that afterward all issues necessary for appeal would have been finally decided.
