ORDER

On July 21, 2014, Appellant filed a notice of appeal indicating he received the underlying order on June 30, 2014. On October 14, 2014, Respondent Alan Wilson filed a motion to dismiss asserting Appellant failed to timely serve the notice of appeal. On October 28, 2014, Appellant filed a proof of service indicating he served the notice of appeal on Respondent Alan Wilson on October 22, 2014.
