

This matter comes before me upon the request of Jerry L. Finney, Esquire, of The Finney Law Firm, to be relieved as counsel for Plaintiff Lloyd Lash in this matter.

Attorney Finney was retained by the Plaintiff in this matter on October 12, 2012 in regards to a civil matter involving a false arrest and false imprisonment following a Jury Trial in March of 2011. Summary Judgment was granted to the Defendants on September 15, 2014, thus dismissing the case. As such, Attorney Finney's representation of Plaintiff ended when the case was dismissed. Plaintiff has acknowledged that the case ended once the case was dismissed and has chosen not to retain Attorney Finney for an Appeal.



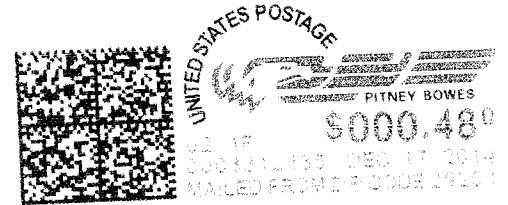
