We are in receipt of your correspondence under date of December 5, 2014. Please find copies of a Certificate of Mailing dated November 24, 2014, and filed of record December 1, 2014, in the Office of the Clerk of Court for the County of Horry, and a Certificate of Mailing dated November 18, 2014, to be filed of record in the Office of the Clerk of Court for the County of Horry, enclosed herewith. I will be converting this information for filing with your court, and have also enclosed an original and one copy of the Proof of Service of the Request for Transcript on Respondent.

We have received the transcript of the hearing held before the Special Referee on May 9, 2014; unfortunately, we have yet to receive the transcript for the hearing held before the Special Referee on September 29, 2014. We ordered transcripts for both hearings, the hearings held on May 9, 2014, and September 29, 2014, from Advantage Court Reporting of Myrtle Beach on November 18, 2014. We received an e-mail from Sunny Fry with Advantage Court Reporting on November 21, 2014, which reflected the hearing on September 29, 2014, was covered by another company, Alderman Court Reporting. We forwarded a Request for Transcript to Alderman Court Reporting on November 25, 2014. On December 3, 2014, we requested a status update from Advantage Court Reporting of Myrtle Beach, and were informed Ryan Alderman with Alderman Court Reporting assisted in locating a court reporter for the hearing on September 29, 2014 hearing, had not appeared at the hearing, and was in the process of attempting to locate the court reporter who has staffed the hearing. This was confirmed by a telephone call from Mr. Alderman. We immediately contacted the person who staffed the hearing, learned she had moved recently moved from Conway to California, and would not return to South Carolina until January of next year. We have formally requested the transcript from Sammi Encarnacion, the person who staffed the hearing, and she is in the process of transcribing the tape. An Amended Request for Transcript has been mailed to the court reporter, and we expect the second of two transcripts shortly.
