
Dear Ms. Kitchings:

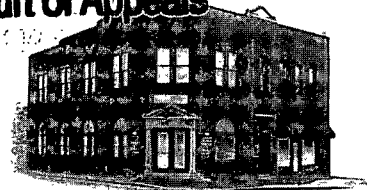


Dear Ms. Bigelow:

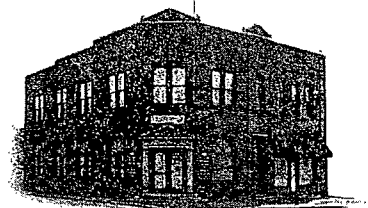

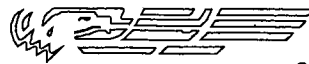
