MOTION FOR AN EXTENSION OF TIME TO FILE
PETITIONER'S BRIEF PURSUANT TO
WHITE v. STATE

Petitioner Clarence Cook moves this Court for an extension of time to file his brief pursuant to White v. State. The basis for Petitioner's Motion is set forth below.

1. On November 20, 2014, this Court granted the petition for writ of certiorari and granted a belated appeal pursuant to White v. State. This Court directed the parties to brief the issues set forth in the Statement of Issues on Appeal attached to the petition. The deadline to file the brief pursuant to White v. State is December 22, 2014.



State with this Court on December 8, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Travis Hair with the Court of Appeals on December 8, 2014. Counsel filed the petition for rehearing in the case of State v. Dominique Shumate with the Court of Appeals on December 1, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Craig Rolen v. State with this Court on November 24, 2014. Counsel filed the petition for rehearing in the case of State v. Julio Hunsburger with the Court of Appeals on November 20, 2014. Counsel had an oral argument in the case of Demetrius Price v. State in this Court on November 20, 2014. Counsel filed the Reply to Brief of Respondent in the case of Darryl Frierson v. State with the Court of Appeals on November 18, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Donald Jones v. State with this Court on November 17, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Julius Curry with the Court of Appeals on November 12, 2014. Counsel filed the reply to the state's return to petition for writ of certiorari in the case of Milo Tudor v. State with this Court on November 6, 2014.

4. This request is made in good faith and not for purposes of delay.

WHEREFORE, the undersigned counsel would respectfully request a thirty-day extension of time until **Wednesday, January 21, 2015**, to file the brief pursuant to White v. State.


