


The defendant did on September 15, 2013 knowingly, willfully, and unlawfully commit the above offense of attempted murder. The defendant did assault and battery the victim, Latoya Abney, about the head and body with a concrete block, concrete flower pot, and personal weapons, "closed fists". The defendant did cause the victim to suffer a head injury along with injuries about the body. This incident took place at 135 Sandy Bottom Drive, within the County of Saluda, State of South Carolina; and is in violation of 16-3-29 of the 1976 South Carolina Code of Laws as amended.
