Dear Ms. Allen:

By this letter, the attorneys for the Appellant-Respondent respectfully request that if the above-referenced case is reached during the March 2015 term of court, it be set for oral arguments during the second week of the term (i.e. March 10-12). The specific grounds for this request are set forth below.

The attorney who will be presenting the oral argument for the Appellant-Respondent has proceedings in a federal court case in San Francisco (*Newton v. American Debt Servs.*, 3:11-cv-03228-EMC (N.D. Calif.)) during the first week of March. Given the time needed to prepare for those proceedings, and to travel to and from California, the attorney would not have sufficient time to participate in oral arguments in South Carolina during the same week.
