Dear Ms. Kitchings:

We are in receipt of Appellant's letter dated December 15, 2014 wherein he advises this Court that it is not necessary to obtain a transcript of the hearing before the Workers' Compensation Panel. Pursuant to Rule 207(a)(1), SCACR, Appellant "shall, within the time provided for ordering the transcript, make satisfactory arrangements (including agreement regarding payment for the transcript), in writing with the court reporter for furnishing the transcript." Furthermore, "[u]nless the parties otherwise agree in writing, appellant must order a transcript of the entire proceedings below." Rule 207(a)(1), SCACR.

Respondents do not agree that the transcript of the hearing before the Appellate Panel of the Full Commission is not necessary, nor do they agree to Appellant ordering less than the full transcript. Because parties are limited to specific amounts of time for argument before the Appellate Panel, the transcript will not be voluminous.
